WAIVER & RELEASE OF LIABILITY FOR MEMBERSHIP/GUESTS

I understand and agree that this release is intended to be as broad and inclusive as permitted under the laws of South Carolina and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I further knowing and voluntarily agree that for any and all Club activities I engage in, I am doing so at my own risk, and I hereby expressly assume all risk of injury, illness, death, or damage to myself or to my property that might result from my participation in any such activity. I certify by signing below that the information I have provided is true and correct and I give consent to the Club to verify any and all of the information provided.

I have carefully read and understand this waiver and release and by signing below acknowledge that I am giving up legal rights and remedies that may be available to me, and am doing so voluntarily. I understand and agree that I am waiving any right I may have to bring a legal action against the Club or its owners for negligence. I also acknowledge that I will abide by all Club policies and rules and understand that failure to do so may result in cancellation of my membership. I agree to inform the Salem Gun & Archery Club Management immediately in the event that my CWP license is revoked or that I become the subject of a prohibition order or similar change in status that effects my ability to legally acquire, possess or be in close contact with firearms. Procedures followed in respect to new members follows

1. A prospective New Member is permitted to attend the Range two (2) times as a "Visitor".
2. The Applicant is then required to complete an Application Form for Membership and pay the application fee and subscription fee.
3. After a probationary period (approximately 10 attendances during which he/she must attend the Range for safety course if not a CWP holder or NRA handgun training graduate). The management may grant him/her full membership, extend his/her probationary period or reject him/her as unsuitable.
4. If granted full membership, the Member is then entitled to all Member benefits. Fees are refunded if application is not approved.
5. Membership period is from the 1st of the application month and continues for 12 calendar months. It is the responsibility of the member to make sure that their membership does not lapse.
6. Pro-rata membership fee is not available.

 - b. Proof of completed CWP class while pending receipt of license
 - c. Copy of certificate for NRA Handgun Safety course.

GENERAL CLUB RULES

1. Treat all firearms as though they are loaded at all times.
2. Always point your weapon in a safe direction. Never point a weapon at anything you are not willing to destroy.
3. All weapons are to remain unloaded and cased unless the shooter is on the firing line.
4. All loading and unloading of weapons will take place on the firing line.
5. Shooters on the firing line shall not break 180 degrees with the muzzle of their firearm. (Under no circumstances will the muzzle point up-range). Shooters shall not point the weapons toward the shooting house roof.
6. Illegal drugs and any and all forms of alcoholic beverages are strictly forbidden from club property. Consumption of alcohol or intoxicants immediately before or during range use is strictly forbidden.
7. Eye and Ear protection are mandatory for all persons for the duration of visit to the Club.
8. A parent or Guardian must accompany minor shooters at all times!
9. Each member is expected to respect and protect club property and report any incident of theft or vandalism to the club owners.
10. Members whose dues are not paid by their annual renewal date will be dropped from the membership of the Club.
11. A separate list of rules will be published to the website: www.gunsmoke1.com and posted on the range. All members are expected to follow these rules when using club facilities.
12. Keys and or codes for accessing the range are the property of Salem Gun & Archery and must be returned upon cancellation or lapse of membership. Keys and door access codes are not to be shared with any persons who have not applied for, paid membership dues, and been granted membership by the Club.
13. Family membership encompasses the primary member, spouse and immediate family members between the ages of 12 and 17 living under the same roof as the registered primary member.
14. Each member is entitled to bring two (2) Guests to the range during a twelve (12) month period. Guests must complete and sign a Release/Waiver form prior to use of the range. Guests are limited to 2 visits after which they must apply for and become a member.
15. No steel or aluminum case ammunition is allowed on the range, period. Members found using aluminum case ammunition will receive one verbal warning. A second infraction will result in membership termination with no refund of membership dues.
